Institute of Hotel Management, Hamirpur has offered following one & half year courses for the academic session 2020-21:-

### Duration

One and a half years, i.e. one year of training in the institute followed by six months of Industrial Training in a hotel/ allotted sector.

### Application procedure

- Application forms can be obtained from the institute on any working day and can also be downloaded from the official website [www.ihmhamirpur.in](http://www.ihmhamirpur.in).
- Duly filled application forms be forwarded to the Principal, IHM Hamirpur so as to reach in the Institute on or before **31.07.2020** by **5:00pm** alongwith application fee of Rs.400/- for Gen/OBC categories and Rs.300/- for SC/ST/PH categories through demand draft drawn in favour of Principal IHM, Hamirpur payable at Hamirpur. The application fee can also be deposited through Debit Card (ATM)/Credit Card at the time of submission of application form.
- Application form received after the prescribed date & time will not be accepted/ entertained.
- At the time of submission of application the candidates are required to produce certificate of physical fitness from Registered Medical Practitioner in the prescribed format.

### Selection Procedure

Selection of candidates will be done strictly according to the merit of eligibility qualification i.e. for Craft Course, merit will be prepared on the basis of marks obtained in 10<sup>th</sup> standard and for Diploma Courses, merit will be prepared on the basis of marks obtained in 12<sup>th</sup> standard. Weightage/ extra marks shall be applicable/ awarded to the candidates having certificates of following achievement:-

- ❖ For One year Craft course from a recognized Institute of Hotel Management or a Food Craft Institute. 3% Marks
- ❖ For representing School/College at State Level in Sports 3% Marks
- ❖ For representing School/College at National Level in Sports 5% Marks

In case of tie in the marks of eligibility qualification (i.e. 10<sup>th</sup> standard marks for Craft course and 12<sup>th</sup> standard marks for Diploma course) candidate having higher marks in English will get benefit. In case of candidate securing equal marks in eligibility qualification as well as in English component, the candidate older in age shall get the benefit.

## RESERVATION OF SEATS

Scheduled Caste Category	5 seats for each course.	
Scheduled Tribes Category	2 seats for each course.	
Physically Handicapped (PH)	1 seat for each course	(See below)

### For Physically Handicapped Candidates:

**a) Orthopedically Handicapped Candidates:** Only those orthopedically Handicapped candidates who have locomotion disability or cerebral palsy with locomotion impairment of minimum of 40% and maximum of 75% and fall in the following categories are eligible to apply.

**B.L. - Both legs affected but not arms**

O.A. - One arm affected (Right or Left)

a) Impaired reach      b) Weakness of grip      c) Ataxia

O.L. - One leg affected (Right or Left)

M.W. - Muscular weakness and limited physical endurance.

**b) Visually Handicapped Candidate**

Only those visually handicapped candidates who suffer from anyone of the following conditions are eligible to apply.

I. Visual acuity not exceeding 6/60 or 20/200 (swollen) in the better eye with correcting lenses.

II. Limitation of the field of vision subtending an angle of 20 degrees or worse.

**c) Hearing Impaired Candidates**

Only those hearing impaired candidates having disability between 40% to 75% shall be eligible.

**d) Learning Disability (Dyslexia)**

Subject to availability of seat after adjustment all the admission to other admissible disable category candidates under section 2 (i) of PWD Act, 1995.

### **MEDICAL CERTIFICATE ISSUING AUTHORITY FOR PH CANDIDATES**

At the time of submission of application, physically Challenged/ Handicapped candidates will be required to attach the copy of Physically Handicapped Certificate issued by the Chief Medical Officer (CMO)
