# Frequently Asked Question (FAQ)

#### Q.1 When the classes of 1<sup>st</sup> semester will commence?

Ans:- The Online classes of 1<sup>st</sup> semester will be commence from 28<sup>th</sup> October, 2020 and the commencement of classes in the Institute are subject to approval of Central & State Govt.

# Q.2 When should I report to the institute?

# Q.4 ATM facility?

Ans: Nearest ATM of PNB bank is approx. 2KM from Institute.

# Q.5 How much fee needs to be paid at the time of reporting at Institute?

Ans: An amount of ₹29,700/- (including miscellaneous fee for student activity)

# Q.6 Uniform?

- Ans: Institute does not subscribe any shop or tailor for the uniform or other Tool Kit required, though you will be given a list of uniform and same may be procured in two weeks time. However following items are mandatory from first day.
  - 1) Black terecot trouser with two plate and 16" bottom. Flat front and low waist is not allowed. (2 pair)
  - 2) White plain full sleeves terecot shirt with one pocket (2 pair)
  - 3) Black shoes oxford model and black socks.

# What documents are required to be brought by the candidate at the time of his physical reporting in the Institute:-

The following documents are required to be submitted:-

- a) Provisional Admission letter issued by NCHMCT in original
- b) Matriculation Certificate OR Certificate of equivalent qualification
- c) 10+2 Qualification Certificate
- d) Character certificate in Original.
- e) School Leaving / Migration Certificate in Original.
- f) Medical Certificate in Original.
- g) 4 Passport Size photographs. ( in white shirt only )
- h) Anti-ragging affidavit by the candidate\*
- i) Anti-ragging affidavit by the parents/guardian\*
- j) A set of photocopies of above documents

# About Hostel

#### Q.1. What is the procedure for hostel allotment?

Ans: Students will apply for hostel seat at the time of their Physical Reporting in the institute. Final list of allotment of hostel will be declared by NCHMCT on the next day of Physical Reporting.

#### Q.2. What are the Hostel charges?

Ans: Rs 60,000/- for academic session 2020-21 (inclusive of 5000/- refundable security).

# **Q.3.** Whether hostel charges are to be deposited by Cash or Demand Draft.

Ans: You can make the payment of hostel fee through ATM (Debit /Credit Card) or by Demand Draft of any Bank in favour of **Principal**, **Institute of Hotel Management**, **Hamirpur (HP)** payable at Hamirpur (H.P)

# Q.4. Being Hosteller what items should I bring with me?

Ans: The Institute will provide you a bed (without matteress), almirah, and study table with chair. Rest all you require to bring as per your individual needs.

# Q.5. Whether bedding is also to be brought or Institute will provide?

Ans: You need to bring your own bedding.

# Q.6. When we can shift in hostel?

Ans: If allotted by the NCHMCT one can shift immediately after depositing the hostel fee.

# Q.7. How many students share a room?

Ans: 2 students are housed in one Room.

# Q.8. When the Mess facility will start?

Ans: The Mess facility will start with the dinner service from the day of Hostel allotment.
